2	V(iii)	If the successful tenderer/bidder/operator fails to achieve the committed Minimum Guaranteed Throughput for 3 consecutive years anytime during the project period after commissioning of the project, permission granted would be liable to be withdrawn by the Board of Trustees on due consideration and examination of the explanations received from the operator/ successful tenderer/bidder for such default.
3	IX(14)	Change in the composition of a Consortium after issue of LoA, if required in exigencies, will be allowed only on one occasion, with prior permission of KoPT, subject to the following conditions: a) The application for such change is received not later than 15 (fifteen) days prior to the stipulated date of signing of the Agreement to allow sufficient time to KoPT to scrutinize the application for change; b) The Lead Member continues to be the Lead Member of the Consortium; c) The substitute is equal or more in terms of Technical and Financial Capacity, to the outgoing Consortium Member and the modified Consortium shall continue to meet the pre-qualification and short-listing criteria for Applicants/ Consortium; d) The incoming Member expressly adopt(s) the Application already made on behalf of the Consortium as if it were a party to it originally, and is not an Applicant which has bid for this Project or Member/ Associate of any other Consortium which has bid for this Project; e) Approval for change in the composition of a Consortium shall be at the sole discretion of KoPT and must be approved by KoPT in writing; f) The reconstituted / modified Consortium shall submit a revised Agreement of forming the Consortium signed by all the members.
