- 4. i) All walls may be made of section wood 2" x 2" framing with 12 mm board which can carry weight of backlit boxes. Lamination or vinyl may be pasted on wall.
 - ii) Outside walls may be made of 4 mm ply covered by mural printed on flex.
 - iii) 10 story boards (5' x 3') and one mural (8' x 5') in vinyl /flex are to be made.
 - a) 8 story boards (5' x 3') should be frontlit.
 - b) 2 story boards (5'x 3') and one mural (8' x 5') should be backlit.
 - iv) False ceiling 1' all through with lamination/acrylic emulsion finish.
 - v) 8 mm glass top round table with SS chairs or bar tools inside pavilion.
 - vi) SS rack inside pavilion.
 - vii) Lighting arrangement in backlit boxes tube lights & wiring.
 - viii) Lighting arrangement in false ceiling as per requirement.
- 5. Front fascia should be exquisitely attractive and should reveal decorative marvel.
- 6. KoPT will provide models which have to be transported and fixed in the stall and brought back to KoPT.
- 7. Acceptance of KoPT's specifications and terms and conditions should be clearly mentioned in the offer.

 - iv. Illumination of the total stall both inside and outside.
