Kolkata Dock System of Kolkata Port Trust is interested to avail Comprehensive Insurance Coverage (Fire and allied peril & Burglary) policies for Computer Servers and other equipments installed at different locations of Kolkata Dock System of Kolkata Port Trust.

Sealed offers / quotations are invited from the eligible Indian Insurance Companies for the items mentioned at Annexure – II in **Single-Bid**. Your offer / quotation should be submitted at the office of Joint Director (P & R), Planning & Research Division, 6th Floor, 15, Strand Road, Kolkata – 700001 on or before the date and time mentioned in "**Last date of submission**".

Scope of Insurance Coverage :

Kolkata Dock System of Kolkata Port Trust intends for Comprehensive Insurance Coverage (Fire and allied peril & Burglary) for Computer Servers and other IT equipments at Kolkata Dock System of Kolkata Port Trust.

Eligibility :

1. The bidder should be an Indian Insurance Company and must be registered and approved by IRDA. The Insurance Company must have its fully functional branch / office at Kolkata.
2. The bidder should have experience of insuring similar type of equipments in large organization with sum assured value not less than the value as mentioned in instant tender.
3. The bidder should submit documentary evidence in support of (1) & (2) along with their bid.

Terms & Conditions :

1. Sealed envelope, superscribed with Tender No. and Date and addressed to Joint Director (P & R), Planning & Research Division, Finance Department, to be submitted at the office of Joint Director (P & R), Planning & Research Division, 6th Floor, 15, Strand Road, Kolkata – 700001, on or before the date and time mentioned at “**Last date of submission**”.
2. Total sum assured amount of Comprehensive Insurance Coverage (Fire and allied peril & Burglary) shall be **Rs. 6,45,95,620/-**, detailed break-up of which is enclosed at Annexure–I. (Details of Computer Servers and other IT equipments is enclosed at Annexure – II)
3. All Insurance coverages shall be effective immediately after the award of tender or as per the valid terms and will remain valid for one year.
4. Claims, if any, against the policies shall be settled within maximum 15 days from the date of submission of claims.
5. Arbitration: Disputes, if any, in respect of operation of insurance policies shall preferably be amicably settled. However, if the disputes are not amicably resolved, the same shall be referred to arbitration as per applicable rules and laws prevailing in India and to be settled in Kolkata.
6. All pages and all corrections (if any) must be signed by the signatory of the bidder, failing which tender will be invalid. However, there should not be any correction, over writing on the price bid. If so, the offer will be rejected.
7. Conditional bids on the scope of work, Terms & Conditions cannot be considered.
8. Kolkata Port Trust reserves its right to accept/reject any bid without assigning any reason thereof.
9. Kolkata Port Trust reserves its right to cancel the tender process or this enquiry any time without assigning any reason thereof.

Validity of Offer :

1. Offer should be valid for minimum 30 days from the date of opening the tender.
2. Bidder's quoted Price should be firm till the completion of insurance coverage period. Quoted price shall be inclusive of all taxes and duties, other charges etc. applicable for the job for a period of one year.

Payment Terms :

1. 100% Premium amount shall be paid by Kolkata Port Trust immediately on submission of bill/ proforma invoice.
2. Price should be mentioned both in Figures and Words in Indian currency.
