### **INSTRUCTIONS TO TENDERERS**

1. Sealed tenders are invited for purchasing of logs and fire woods of different varieties and sizes belonging to Haldia Dock Complex, Kolkata Port Trust.
2. The interested tenderers shall submit lump sum quotation in the price bid given at Annex - I of this Tender Document.
3. The interested tenderers shall be deemed to have carefully inspected the logs and fire woods scheduled for disposal and have fully understood the instruction to tenderers. In this regard, they may contact the officers concerned of Admn. Division, Haldia Dock Complex on any working day from 10-00 hrs. to 16-00 hrs. at phone nos. 03224 264555 or 03224 265811 for inspection of the materials scheduled for disposal.
4. The tenderer shall submit two separate sealed envelopes in the main envelope as follows:-

1<sup>st</sup> Envelope duly superscribed with "**Copy of Tender Document & Earnest Money**" shall contain the following:-

- a) Copy of the tender document duly signed with seal at all pages by the tenderer as token of acceptance of all the terms and conditions of the tender.
- b) Receipt of deposition of Earnest Money amounting to Rs 5200/- in cash at the Cash Office of Manager (Finance) at the Ground Floor of Jawahar Tower or by Demand Draft / Bankers Cheque of any scheduled Bank of India in favour of "Kolkata Port Trust, Haldia Dock Complex" payable at Haldia.

2<sup>nd</sup> Envelope duly superscribed with "**Price Bid**" shall contain the price offer as per format at Annex-I of the Tender Document.

3<sup>rd</sup> Envelope will be main Envelope superscribed with "**Tender for disposal of logs and fire woods by Haldia Dock Complex, Kolkata Port Trust**" and shall contain the 1<sup>st</sup> and 2<sup>nd</sup> Envelope.

- 5a) The 1<sup>st</sup> Envelope will be opened first to ensure that the tenderer has submitted Earnest Money and copy of the Tender Document duly signed.
- 5b) The tenderer who will not submit Earnest Money shall be rejected outright and his price bid will not be opened.
- 6) The tender including price bid shall remain valid for acceptance for a period of 90 days from the date of opening of the tender.
- 7) The Trustees reserve the right to accept or reject any tender either in part or in full without assigning any reason. Any incomplete tender is liable to be rejected.
- 8) The price bid of only those tenderers will be opened who will submit the Earnest Money and accept all the terms and conditions of the tender by unconditionally signing the tender document and submitting the same with the tender.

#### **THE TERMS AND CONDITIONS OF THE TENDER:**

##### **Commercial Part :**

1. **Payment:**

The successful tenderer shall have to pay the quoted amount as accepted by KoPT in the form of Bankers Cheque / Demand Draft drawn on Haldia Dock Complex, Kolkata Port Trust from any scheduled bank or in cash within 10 days from the date of placement of order. If any successful bidder fails to deposit the requisite money within the stipulated date, penalty shall be imposed @ 1% of the total order value for delay of every week of part thereof.

2. The successful tenderer shall have to remove the logs and fire woods as per order within 15 days from the date of placement of order. In the event of failure to remove the material within 15 days from date of placement of order, the successful tenderer shall have to pay @ 1% of the contracted amount as penalty for every week or part thereof the work remains unfinished.

3. **Evaluation Criteria :**

Subject to fulfilling all required conditions including acceptance to terms & conditions of the tender, evaluation of the offer will be based on the maximum financial realization to the Port.

4. **Safety measures:**

The successful tenderer will take all possible safety measures in respect of labours, vehicular traffic & KoPT/HDC's property during lifting and removal of the logs and fire woods. Successful tenderer shall be held responsible for any damages, accident etc. on account of lapses on his part and in that case, he will be liable for repair/ replacement of the port property at his own cost and arrangement.

5. Successful tenderers shall be required to pay statutory taxes & duties, if applicable over and above their quoted offer.

6. **Security**

From the date of receipt of firm order, successful tenderer shall have to make his own security arrangement for guarding the disposed items at the premises concerned till removal of such items by him.

7. **Permission to carriage**

During transportation of his purchased materials, successful tenderer shall obtain necessary permission, if required, from the appropriate authority(ies) at his own arrangements.

8. **Termination of contract**

If at any time after placement of the order, it is observed that the successful tenderer is taking inordinately long time for removal of the disposed items or his performance in any manner is found unsatisfactory, Manager (Admn.), Haldia Dock Complex shall terminate full or part of the contract after giving 7 days notice and his decision in the matter shall be final and binding on the successful tenderer.
