1.0 GENERAL:

These provisions though given in a separate section are part of the tender documents which must be read as a whole, the various sections being complementary to one another and are to be taken as mutually explanatory. These provisions shall be read in conjunction with the other parts of the tender documents viz. General Conditions of Contract, Notice Inviting Tender, Instructions to Bidders, Bill of Quantities and other documents forming part of the Contract. In case of any discrepancy or ambiguity in the documents, the order of precedence of the documents as stated below will apply. In particular, these provisions will over ride those in the General Conditions provided there is discrepancy between them.

2.0 CORRELATION AND ORDER OF PRECEDENCE OF TENDER DOCUMENT:

If the stipulations in the various tender documents be found to be at variance in any respect, one will override others (but only to the extent these are at variance) in the order of precedence as given in the list below, i.e. any particular item in the list will take precedence over all those placed lower down in the list.

- Order letter.
- Bill of Quantities.
- Drawings (if any).
- Particular Specification.
- Special Conditions of Contract.
- General Conditions of Contract.

In case of any dispute, question or difference either during the execution of the work or any other time as to any matter or thing connected with or arising out of this Contract, the decision of the Sr. Dy. Manager IZ&R, (I&CF), Haldia Dock Complex, thereon shall be final and binding upon all parties.

3. SCOPE OF WORK:

The work comprises of supplying, delivering, carrying, positioning and placing the Water Tank Tailor as per attached specifications and as stated in Bill of Quantities to the Dock store, RZ store and IZ&R store of I&CF Division of Haldia Dock Complex, as per the direction of the Engineer or his representative.

The Contractor shall take all possible care so that other construction, traffic movement and / or operational works and office works around the area, if any, are not unduly hampered for his work.

4.0 LOCATION & ACCESS TO THE SITE:

(a) By Road:

The supply is to be made at Dock store, RZ store and IZ&R store of I & CF Division of Haldia Dock Complex. All weather hard top roads approachable from NH-41 exist right up to the area of work.

(b) By Rail:

S. E. Railway Branch Line connects Haldia with the Panskura Railway Station.

5.0 PRICING OF BID:

- 5.1 Rate should be quoted F.O.R. Trustees' Store Yard at Haldia i.e. on free delivery basis including unloading, manual carriage placing and positioning.
- 5.2 Price(s) to be quoted must remain firm till the goods are delivered. No Price Escalation is admissible.
- 5.3 The quoted prices must include all charges, such as Govt. Excise Duty, Sales Tax etc, as applicable, permits, overheads, profit, transit insurance ,charges for packing, loading, forwarding, transportation, unloading, positioning and placing at the Stores at Haldia etc.
- 5.4 Please note that Ko.P.T does not provide any concessional Sales Tax Form.

6.0 TESTING:

- 6.1 Testing shall have to be done on selected materials required for manufacturing the Tank as per direction of the Engineer.
- 6.2 The bidder shall include the necessary testing charges, cost of sampling, cost of dispatching the sample etc. and all other expenses related thereto in his rates and the contractor shall not be paid any additional amount in this regard.
- 6.3 Physical inspection shall be done by the Engineer or his authorized representative.
- 6.4 Notwithstanding the inspection and passing of materials, any sample found to be defective in quality and not conforming to the specification as per the relevant specification due to any reason whatsoever, shall be liable to rejection and the contractor shall replace the same at his own cost and arrangement at the earliest.

7.0 DESPATCH ARRANGEMENTS:

Materials shall be delivered by the successful Bidder at their own cost, risk and responsibility at the store of I&CF Division of Haldia Dock Complex. The supplier shall send advance intimation as to the actual date of delivery of each and every installment of supply. Delivery of materials will not be accepted on Sundays and Holidays. No Lorry shall be permitted into the protected area during night-time. Detention of Lorries, if any, will be on Supplier's account.

8.0 DELIVERY:

- 8.1 Supply and delivery against the subject work has to be completed within **02(two)** months from the date of issuance of Work Order.
- 8.2 The authorized representative of the supplier must be present at the time of delivery for jointly noting the quantity of material delivered with the representative of Ko.P.T. Delivery will not be accepted if not accompanied by proper delivery challans (in quadruplicate), & Guarantee Certificate.
- 8.3 In case of default in supply or failure to deliver as per correct specification or the approved quantity within the time stipulated, Trustees are entitled to purchase from another source at the risk, cost and expenses of the supplier, the whole or any portion of the supply remaining undelivered or unapproved.

9.0 REJECTED MATERIALS:

The supplier shall remove rejected materials within fortnight from the date of rejection of the materials. Such rejected materials shall be at contractor's risk. If the contractor fails to remove such materials within a fortnight of rejection, the Trustees shall have the right to dispose of the same and the Contractor shall have no claim against the Trustees in respect of the said rejected materials. For removal of the rejected materials, the Contractor shall obtain a prior written approval of the Engineer on furnishing the details or quantity, location, mode of transport, date and time of removal and the person authorized to lift the rejected materials etc.

10.0 TIME OF COMPLETION:

The entire supply must be completed in all respects within **02 (two) Months** including preliminary time from the date of placement of work order.

11.0 PAYMENT:

- 11.1 Payment at the accepted rate will be made after satisfactory supply of Water Tank Trailer on submission of Bill accompanied by Challan, Guarantee Certificate duly signed by the consignee or their authorized representative. The Bills should be submitted in quadruplicate to the Sr. Dy. Manager IZ&R, (I&CF)'s Office with necessary documents in original.
- 11.2 HDC will make payment directly to the contractor's designated bank account. - 11.3 Payment will be made within 30 (thirty) days of receipt of complete and satisfactory supply and on submission of clear Bill.

12.0 SAFETY MEASURES:

The contractor shall adhere to safe practice while loading / unloading, positioning, placing and carriage of the Water Tank Trailer.

13.0 **PERMIT**:

Permits for entering the Dock Zone of HDC will be necessary for the workmen and for the movement of transport vehicles for this work. In the interest of work, necessary permits will be issued **free of cost** by the Trustee's, against application by the contractor, after the same is examined and approved by the Engineer. All existing rules, including any amendments thereto, in future, will have to be complied with by the contractor.

14.0 'LIQUIDATED DAMAGES' FOR DELAY:

If the Contractor fails to execute the contract partly or for the whole of the works, as applicable, within the stipulated dates or such extension thereof as communicated by Manager(I&CF) in writing, then the Contractor shall be required to pay to the Trustees' the @ ½ % of the Contract Value of the UNDELIVERED materials for every week or part there of the supply remains undelivered , provided always that the amount of such compensation under the provision of this clause does not exceed 10 % (TEN PERCENT) of the contract value of the goods.

The Trustees' may, without prejudice to any other method of recovery, deduct the amount of such damages from any monies due or to become due to the Contractor.

The payment or deduction of such damages shall not relieve the Contractor from his obligation to complete the Works, or from any other of his obligations and liabilities under the Contract.

In case the bidder fails to complete the supply, some other agency may be ordered to supply the remaining materials at the risk & expense of the Bidder after a minimum three days notice in writing has been given to the bidder by the Manager (I&CF) or his representative. Deployment of separate agency shall be at the absolute discretion of the Manager (I&CF), whose decision will be final & binding.

15.0 FORCE MAJEURE:

In the event of either party rendered unable by Force Majeure to perform any obligation required to be performed by them under the Contract, relevant obligation of the party affected by such Force Majeure shall upon notification to the other party be suspended for the period which Force Majeure events lasts. The cost and loss sustained by the either party shall be borne by the respective parties.

The term "Force Majeure" as employed shall mean but not restricted to the events as below:

- (i) Riot (unless solely restricted to or perpetuated by employees of the Contractor /suppliers or occurring outside India) so far as it is uninsurable.
- (ii) War, hostilities (whether war be declared or not), invasion, directed to or by India or act of foreign enemies, directed to India.
- (iii) Rebellion, revolutions, insurrection, or military or usurped power, or civil war in India.
- (iv) Fire, flood, cyclone, hurricane and acts of God. Upon the occurrence of such cause and upon its termination, the party alleging that it has been rendered unable as aforesaid shall notify the other party in writing immediately but not later than forty eight hours of the alleged beginning and ending thereof, giving full particulars and satisfactory evidence in support of his claim. Time of performance of the relative obligation suspended by the Force Majeure shall stand extended by the period for which such event lasts and affects the relative obligation directly.
