TECHNO COMMERCIAL PART

TERMS & CONDITIONS FOR PROCUREMENT OF MEDICINAL CHEMICALS

1.0 SCOPE OF WORK:

The work comprises of supplying the Medicinal Chemicals (as stated in the enclosed bill of quantities) & as per purchase order to be issued to the bidder(s). Prices are to be quoted against the items mentioned on the Annexure – C of Price Part.

2.0 DELIVERY:

Ordered items should be supplied within thirty (30) days from the date of placement of order at Port Hospital, Haldia Dock Complex. Supplied materials should be from fresh batch and items having printed date of expiry should be supplied with at least two-third (2/3rd) of the shelf life remaining at the time of delivery. Required quantity mentioned against each item in the tender document may be split into any number of orders over one year from the date of opening of tender. Delivery of materials will not be accepted on Sundays and Holidays of Haldia Dock Complex, Kolkata Port Trust.

The successful bidder(s) must make his / their own arrangements at their own cost for delivery of all materials, as well as for careful and proper unloading and stacking at HDC's Medical Division store. The responsibility for preventing damage / deterioration of the materials during transit, delivery, unloading and stacking at the designated point shall rest with the bidder.

At the time of delivery if any material is found to be defective in quality and not conforming to the relevant specification, the same shall be liable for rejection and the bidder(s) shall replace the same at his / their cost and arrangement at the earliest.

3.0 PRICING OF BIDS:

3.1 Rate should be quoted all inclusive i.e. packing, transport, delivery at Port Hospital and all other charges (if any) involved. No separate payment will be made for transport and delivery of items.

3.2 Quoted rate(s) should remain FIRM till the full ordered materials are delivered. Quoted rates(s) should be valid for one year from the date of opening of bid.

3.3 The bidder(s) should indicate the percentage (%) of GST, and other statutory levies as applicable, showing break-up of the above cost elements in his / their offer. Please note that Haldia Dock Complex does not provide any sale tax declaration form.

4.0 **PAYMENT:**

Payment would be made through Bank ECS after satisfactory receipt of the ordered materials within 30 (thirty) days of submitting the clear bill. The bills should be submitted in quadruplicate to Medical Superintendent's Office with necessary documents (if any) in original. Accordingly, bidder(s) is / are requested to submit his / their bank Account No. with the name and address of the bank along with the branch name and IFS code number of the Bank while submitting the bill.

5.0 **INSPECTION:**

Inspection of materials would be done by HDC's authorized representative prior to acceptance at Port Hospital, Haldia Dock Complex. The materials supplied by the supplier should strictly conform to the laid down specifications of tender / order.

6.0 **VALIDITY:**

The offer shall remain open for acceptance up to 60 (sixty) days from the date of opening of tender.

7.0 **EVALUATION:**

Evaluation will be on the minimum rate (inclusive of all i.e. statutory levies, delivery charge etc) quoted against individual items.

The Trustees are not bound to accept the lowest or any tender and reserve the right to accept a tender in full or in part and / or reject tender in full or in part without assigning any reason thereof.
