

E-Tenders are invited reliable, bonafide, resourceful, experienced and reputed firms of enlisted contractor of SMP for the following work.

Name of Work: "Providing & Supplying different category of labourers with necessary tools & tackles as and when required for misc. Works at various sites under the jurisdiction of Supdt. Engineer (south division) for a period of one year from the date of placement of work order."

Estimated Amount: **₹ 4,28,931.75 (Rupees Four Lakh Twenty Eight Thousand Nine Hundred Thirty One and Paise Seventy Five only)**
Date of Completion: **01 (one year)**

Tender documents will be issued to only those contractors satisfying the following eligibility criterion as mentioned below: -

"Tenderer should have experience in completing **similar works or construction/maintenance of different types of** buildings / industrial including plumbing and sanitary works during the ending during last 7 years ending at the last day of the month previous to the one in which applications are invited which should be either of the following: -

01. (a) Three similar completed works each costing not less than the amount equal to 40% of the estimated value.
(b) Two similar completed works each costing not less than the amount equal to 50% of the estimated value.
(c) One similar completed works each costing not less than the amount equal to 80% of the estimated value.
Similar work means up keeping and general maintenance of buildings/sheds etc or similar works like deploying of labours at different works
02. (a) All intending tenderer at the time of tender shall disclose all necessary documents proof of registration with ESI

Tenderers are required to furnish relevant documentary evidence in the above regard. In case of any non-conformity to the same, the concerned tenders would be liable to be rejected”.

- 3 (a) The successful tenderer will be required to comply with the relevant provisions of Building and other construction workers (Regulation of Employment and Conditions of Service) Act, 1996 and West Bengal Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 2004 as well as Building and Other Construction Workers' Welfare Cess Act, 1996 and rules framed there under.
- (b) An amount of cess calculated at the rate of 1% of the billed amount shall be progressively recovered from each running bill as well as from the final bill of the contractor for onward transmission of the same to the appropriate authority.
