## **SCOPE OF WORK & SPECIFICATION:**

- 1. Gland along with seals of Hydraulic Pump which has been found leaky is to be replaced.
- 2. Out of the 6 nos. Pulley of the Top Pulley Block (diversion pulley) Assembly of main hook, 2 nos. pulleys with bush to be replaced. Bushes of the rest 4 nos. pulley are to be replaced.
- 3. Arrangement to reeve two nos. main hoist steel rope of length 345 miter each over crane pulley block assembly, which is lying in-store.

4. Dismantling and repairing / overhauling of the 2 nos. hoisting limit switches (one for the main & other for the auxiliary). Assembling of the same after proper repairing / overhauling and to set right of the same.

5. Checking and servicing of the 4 nos. pulleys of the bottom pulley block assembly of 60 Ton main hook.

## **TERMS AND CONDITIONS:**

- 1. You should take actual relevant measurements of the machinery for manufacturing purpose and manufacture the above items so that there is no problem for installation and commissioning at the existing location of installation. Measurement should be taken from the existing items without dismantling the same.
- **2.** Material Test Certificate of MOC of all the items of manufacture under 'Scope of Work' from Govt. approved Test House is to be provided with the delivery of item.
- **3.** The entire work of manufacturing and testing is to be inspected by EE (DBM) and his authorized representative and certified accordingly by the inspectors.
- **4. Payment Terms**: 97% payment will be made after completion of commissioning and satisfactory trial of the crane with acceptance of the same by Executive Engineer, DD or his authorized representative and the balance 3% will be retained as Security Deposit which would be released after successful completion of guarantee period.
- 5. Security Deposit: 3% of the total contract value would be kept as Security Deposit and such sum shall be deducted from bills and would be refunded after expiry of the guarantee period.
- **6. Guarantee Period:** The entire work shall remain guaranteed for a period of six month from the date of successful installation, trial & commissioning.
- **7.** Completion Period : The total completion time for the job is 30days from the date of site clearance by KoPT. The total completion time of 30 days shall be calculated cumulatively from the date of clear expressed permission from KoPT to commence the job as mentioned above till the certification by KoPT of satisfactory work completion. The period of any disruption/stoppage of work due to operational urgency of KoPT shall not be counted while calculating the completion period. However, such disruption/stoppage of work has to be recorded in 'Hindrance Register' to be maintained by the contractor and to be countersigned by the representative of Executive Engineer(DBM/KPD).
- 8. Liquidated Damage : : In case the work is not completed within the stipulated completion period, liquidated damage @ 1/2 % per week subject to a maximum of 10% of the ordered value will be deducted from the bill.
- **9. Dock Permit**: Dock Permits for entry of your workmen, materials, transport etc. wherever required, would be provided by KoPT free of cost.
- 10. Electricity if required will be provided by KoPT on free of cost.
- **11.** Transportation: All charges to be borne by the Contractor.
