Syama Prasad Mookerjee Port, Kolkata (Erstwhile Kolkata Port Trust) invites Expression of Interest (EOI) from experienced parties for development of Railway sidings along with allied facilities for handling of railway wagons.

#### 1. Objective

Kolkata Dock System under Syama Prasad Mookerjee Port, Kolkata handles various types of cargo dry bulk, Liquid bulk, break bulk, container etc. Railway coefficient or cargo handled through railway system of KDS is 14% which can be further increased by developing more railway sidings in Port vicinity. Being a city based Port there is severe traffic restriction imposed on road bound traffic so new railway infrastructure to handle more cargo through railway is envisaged, which may further increase the cargo throughput in KDS.

There are two plots D/E & BSNL plots which are going to be developed. D/E plot is measuring about 15970 sqm in area and the approach road is from Sonai Road and half rake can be placed there at a time. BSNL land area needs to be ascertained by bidder & railway access to the said site is from the FCI serving line. A branch off line towards the BSNL main gate may be considered for development for half rake handling. The land rental rate for the said areas is Rs 4668.19 per 100 sqm per month. For rail served plot, 15% extra is to be paid so the final rate is Rs.5368.42 per 100 sqm per month.

Interested parties may submit their interests against this EOI by highlighting various alternatives like equipments to be deployed, land area needed including capacity to handle rakes per day, the period of the contract, to be made through a tendering process subsequently for the above purpose. The broad scope of work as have been envisaged by SMPK is given below:-

#### 2. Broad Scope of Work

The scope of work shall include but not limited to the following operations:

- 1) Development of Wagon loading/unloading facility at BSNL & D/E plots by providing logistics & manpower support, arrangements of power supply, water supply, construction of entry & exit gates and yard for cargo storage.
- 2) Performing the following operation as per the request received by Port from users.
  - a) Loading/Unloading of cargo onto/from wagon and stacking of cargo if required.
  - b) Reclamation of spilled cargo from the wagon loading & truck loading platforms and adjoining areas.
- 3) Operation should be available in all the three shifts as per requirement of users.

Interested parties may suggest any other items work i.e. essential for successful implementation of operation at railway sidings.

# 3. Eligibility Criteria

- 1) Bidder should be Service Provider / Contractor of having existence in the business of Loading/Unloading & Associated activities in wagon.
- 2) Bidder must not be blacklisted by any government department/public sector undertaking/co-operative Unit. Bidder must not be delisted / on Negative List by any government department/public sector undertaking/co-operative Unit in the last two years, as on date of participating in the tender.

### 4. Special Conditions

- a) SMPK would prefer to enter into a contract for a specified period. Pursuant to the evaluation of the instant Eol, where bidders are supposed to indicate all feasible alternatives in their proposals for the system concerned, terms of the tender would be finalized for entering into a subsequent contract.
- b) The bidders are to indicate their requirements in terms of number & types of equipment to be involved, amount of space required, cost involved, period of tender.
- c) SMPK will not assure any Minimum Guaranteed Traffic (MGT) for the work to be carried out by the successful bidder.
- d) Refurbishment of defunct rail track near sidings will be borne by Port. Port will also provide the land/space on licensee payment basis and will provide locomotive for shunting operation, necessary local haulage & Terminal charges will be realized from Customer. Concessions available for the said charges for EXIM or Domestic cargo will be continued for another 2 years and reviewed thereafter.

# 5. Final decision making authority

SMPK reserves the right to accept or reject any application and to annul the process and reject all applications at any time without assigning any reason thereof and without thereby incurring any liability to the affected applicant or without informing the applicants of the grounds for such action by SMPK.

#### 6. Submission Requirement

The applicants shall provide documentary evidence to SMPK of their eligibility and their capability and adequacy. In addition, the interested firms are requested to submit technical and commercial proposals giving details of the facilities intended to be created at the project site. The proposal shall include the following:

- 1. Brief particulars of the firm along with the nature of business/industry
- 2. Plans for equipping/ operation/manning the sidings.
- 3. Target size or expected volume of cargo.
- 4. Cost (Capital & operational) involved, period of project in months & ROI.
- 5. The amount of land (in sq.mtr.) necessary for the project
- 6. Other facilities expected from Port, if any
- 7. Details/ documents of Experience.
- 8. GST Registration Certificate
- 9. PAN

#### 7. Language of Application

The language of the Application shall be in English only.

### 8. Submission of EOI

## A) Number of EOIs

An Applicant is eligible to submit only one Application.

### B) <u>EOI Submission Date</u>

EOI must be submitted, as per the prescribed date and time

### C) <u>Late Submission:</u>

EOI received after the deadline for submission prescribed by SMPK will be rejected.

# 9. Modifications and Withdrawal of EOI

No modifications/ withdrawal of the EOI shall be allowed once it is received by Syama Prasad Mookerjee Port, Kolkata.

# 10. Jurisdiction

All disputes arising shall be subject to the jurisdiction of the appropriate court in Kolkata, India and will be governed by the laws of India.
