

## SCOPE OF WORK :

1. Dismantling and erection with alignment of Hydraulic Cylinder in underwater condition.
2. Fixing of Cotter Pin of Coupling Connecting Piston Rod and Connecting Rod in underwater condition. Cotter Pin, if required, shall be supplied by KoPT.
3. Complete Oil Seal change for Penstock Hydraulic Cylinder of size 250NB with supply of Seal.
4. Removal of Connecting Rod in underwater condition.
5. Fitting of Connecting Rod in underwater condition
6. Cleaning of Pit.
7. Chrome Plating of Piston Rod of Penstock.
8. Manufacturing of coupling connector of Piston rod and connecting rod of Penstock.

## TERMS AND CONDITIONS:

1. **Indemnity Bond:** The successful Tenderer shall have to execute an Indemnity Bond of Rs.2 Lakhs on a non-judicial stamp paper of at least Rs.50/- in the format to be furnished by SMP, Kolkata before taking any major component/assemblies/sub-assemblies like Hydraulic Cylinder or Piston Rod out of premises of Dock for repair
2. **Payment Terms:** 97% of the contract price shall be paid on commissioning of Penstock after satisfactory completion of work as per scope of work mentioned above and issuance of work done certificate by the Executive Engineer (Docks-NSD).
3. **Mode of Payment:** All payment will be made through Electronic Clearance System (ECS). To facilitate payment through ECS, the tenderers will have to furnish the following information. The account shall have to be with a bank within the ECS zone prescribed by the RBI.

4. **Security Deposit:** 3% of the total contract value would be kept as Security Deposit and such sum shall be deducted from bills and would be refunded after expiry of the guarantee period.
5. **Guarantee Period:** The entire work shall remain guaranteed for a period of 6 months from the date of successful installation, trial & commissioning.

6. **Completion Period** : The total completion time for the job is 21 days from the date of site clearance by SMP,Kolkata. The total completion time of 21 days shall be calculated cumulatively from the date of clear expressed permission from SMP,Kolkata to commence the job as mentioned above till the certification by SMP,Kolkata of satisfactory work completion. The period of any disruption/stoppage of work due to operational urgency of SMP,Kolkata shall not be counted while calculating the completion period. However, such disruption/stoppage of work has to be recorded in 'Hindrance Register' to be maintained by the contractor and to be countersigned by the representative of Executive Engineer(Docks-NSD).
7. **Liquidated Damage** : : In case the work is not completed within the stipulated completion period, liquidated damage @  $\frac{1}{2}$  % per week subject to a maximum of 10% of the ordered value will be deducted from the bill.
8. **Dock Permit**: Dock permit for entering inside the dock shall be provided by SMP, Kolkata free of cost against application for the required number of heads for the required number of days, against one-time payment per head for generating computerized identification or at a rate as may be revised during the pendency of the contract. Dock permit for vehicle required for the contracted work would also be given free of cost.
9. The contractor shall at his own cost protect, support and take all precaution with regard to the personnel, structure, services or properties belonging to Port Authority which may be interfered with or affected or disturbed or endangered and shall indemnify and keep indemnified the Port Authority against claim for injury, loss or damage caused by you in connection with execution of the contract.
10. **Damage and loss to private property and injury to workmen**: The shall at his own expenses reinstate and make good to the satisfaction of SMP, Kolkata and pay compensation for any injury, loss or damage accrued to any person, property or rights whatever including property and rights of SMP, Kolkata (or Agents/servants or employees of SMP, Kolkata), the injury, loss or damage arising out of or in any way in connection with the execution or purported execution of the contract and further the contractor shall indemnify SMP, Kolkata against all claims enforceable against SMP, Kolkata (or any Agent, servant or employees of SMP, Kolkata) or which would be so enforceable against SMP, Kolkata where SMP, Kolkata is a private person, in respect of any such injury (including injury resulting to death), loss or damage to any person whomsoever or property including all claims which may arise. All expenses towards injury/damages of the contractor own personnel only would be borne by the contractor. The contractor will not take any liabilities for consequential damages to manpower (non-contractor personnel) or to material/ infrastructure.
11. Any insurance coverage shall have to be arranged by you at your own cost and liability.
12. **Electricity** if required will be provided by SMP,Kolkata on free of cost.
13. **Transportation**: All charges to be borne by the Contractor.
14. All other terms and conditions excepting those mentioned separately shall be governed by SMP, Kolkata's General Conditions of Contract.
