- (ii) The bidder shall not impose his own terms & conditions in his offer or quote his rates based on his own terms & conditions, such tenders are liable to rejection at the option of the Trustees without further reference to the bidder.
- (iii) All materials to be supplied by the successful bidder (s) shall be of the best and approved quality conforming to relevant specifications.
- (iv) All measuring units are in Metric System and rates and sums in the tender are in Indian Currency. The language used through out shall be in English.
- (v) The tender documents with all the enclosures, appendices, Abstract Form of Tender and Form of Tender shall be required to be complete, duly filled in and signed in every page of the tender.
- (vi) The bidder shall give a declaration about the names of their relations employed in Kolkata Port trust. It is not the intention to debar the Contractors from working if their relatives are working in Ko.P.T., but such a declaration is necessary in the interest of Trustees against any possible lapses.

CONDITIONS OF CONTRACT

1.0 GENERAL

These provisions though given in a separate section are part of the tender document which must be read as a whole, the various sections being complementary to one another and to be taken as mutually explanatory. These provisions shall be read in conjunction with the other parts of the tender documents viz., General Conditions of Contract, Notice Inviting Tenders, Instructions to Bidders, Bill of Quantities and other documents forming part of the Contract. In case of any discrepancy or ambiguity in the documents, the order of precedence of the documents as stated below will apply. In particular, these provisions will over ride those in the General Conditions provided there is discrepancy between them.

2.0 CORRELATION AND ORDER OF PRECEDENCE OF TENDER DOCUMENTS:

If the stipulations in the various tender documents be found to be at variance in any respect, one will over ride others (but only to the extent these are at variance) in the order of precedence as given in the list below, i.e. any particular item in the list will take precedence over all those placed lower down in the list.

- ==> Order Letter.
- ==> Bill of Quantities.
- ==> Drawings (if any).
- ==> Conditions of Contract.
- ==> General Conditions of Contract.

In case of any dispute, question or difference either during the execution of the work or any other timeas to any matter or thing connected with or arising out of this Contract, the decision of the Manager (I&CF), Haldia Dock Complex, theron shall be final and binding upon all parties.

3.0 SCOPE OF WORK:

The work comprises of supplying including loading, unloading, stacking adjustable self reversing point lever box sets to P.W.Stores of I&CF Division, Haldia Dock Complex at Chiranjibpur as per the direction of the Engineer or his representative

4.0 LOCATION& ACESS TO THE SITE:

The supply is to be made at Trustees P.W.Stores at Chiranjibpur, Haldia. All weather road / laterite road approachable from N.H. 41 exist right upto the area of work.

- (c) By Rail:
- S.E.Railway Branch Line connects Haldia with the Panskura Railway Station.

5.0 PRICING OF BID:

Rate should be quoted F.O.R. Trustees' Store yard at Haldia i.e. on free delivery basis including unloadin and stacking. Price(s) to be quoted must remain firm till the goods are delivered. No Price escalation is admissible other than statutory increase in taxes, duties etc. / imposition of new taxes and duties after last date of submission of tender. The quoted price must include all charges, such as Govt. Excise Duty, Sales Tax etc. as applicable, permits, overheads, profit, and charges for packing, loading, forwarding, transportation and transit insurance, unloading and stacking at the Stores at Haldia etc.

Please note that KoPT does not provide any concessional Sales Tax Form.

6.0 INSPECTION:

The equipments are to be inspected and passed by RITES or any other inspection agency duly approved by the Engineer. Necessary "Call Letters" are to be issued to the inspecting authority by the supplier well in advance to ensure timely supply with a copy endorsed to Manager (I&CF) i.e. the Engineer. Necessary inspection charges including ancillary costs are to be borne by the contractor and shall be included in the quoted rates.

Notwithstanding the inspection and passing of materials by RITES, any material found at the time of delivery to be defective in quality and not conforming to the specified shape, size and weight as per the relevant drawing and specification due to any reason whatsoever, shall be liable to rejection and the supplier shall replace the same at his own cost and arrangement at the earliest.

7.0 DELIVERY:

Supply and delivery against the work has to be completed within 02 (TWO) months from the date of issuance of work order. Maximum 2 part delivery will be allowed.

The authorised representative of the supplier must be present at the time of delivery for jointly noting the quantity of material delivered with the representative of Ko.P.T. Delivery will not be accepted if not accompanied by proper delivery challans (in quadruplicate), Inspection Report from RITES.

In case of default in supply or failure to deliver as per correct specification or the approved quantity within the time stipulated, Trustees are entitled to purchase from another source at the risk, cost and expenses of the supplier, the whole or any portion of the supply remaining undelivered.

8.0 GUARANTEE:

The material shall have to be guaranteed against manufacturing defects by the supplier for a period of 12 (twelve) months from the date of final completion/acceptance. If any defect, whatsoever, develop during this guarantee period, the same will have to be rectified / repaired[as the case may be] by the supplier at their own cost. A Guarantee Certificate to this effect shall be submitted by the supplier along with the Bill.

9.0 TIME OF COMPLETION:

The entire supply must be completed in all respects within **2 (Two) months** including preliminary time from the date of placement of work order.

10.0 PAYMENT:

- Payment at the accepted rate will be made after satisfactory supply of materials on submission of Bill accompanied by Challans, Inspection Report, Guarantee Certificate duly signed by the consignee or their authorised representative. The Bills should be submitted in quadruplicate to the Manager (I&CF)'s Office with necessary documents in original.
- ⇒ HDC will make payment directly to the contractor's designated bank account. For the purpose, the contractor will have to indicate (i) name of bank, (ii) branch name, (iii) branch code and(iv) designated account number in the "Abstract Form of Tender" In case payment is made directly through bank, the contractor may be required to submit a pre-receipt as per instruction of HDc.
- ⇒ Payment will be made within 30 (thirty) days of receipt of complete and satisfactory supply and on submission of clear Bill.
- Maximum 2 part payments will be allowed.

11.0 SAFETY MEASURES:

The contractor shall adhere to safe practice while loading / unloading, stacking and carriage of the materials.

12.0 PERMIT:

Entry Permits will be necessary for the workmen and for the movement of transport vehicles for this work. In the interest of work, necessary permits will be issued **free of cost** by the Trustee's Against application by the contractor, after the same is examined and approved by the Engineer. All existing rules, including any amendments thereto, in future, will have to be complied with by the contractor.

13.0 'LIQUIDATED DAMAGES' FOR DELAY:

If the Contractor fails to execute the contract partly or for the whole of the works, as applicable, within the stipulated dates or such extension thereof as communicated by by Manager (I&CF) in writing, then the contractor shall be required to pay to the Trustees @ ½ % of the Contract Value of the UNDELIVERED materials for every week or part there of the supply remains undelivered, provided always that the amount of such compensation under the provision of this clause does not exceed 10% (TEN PERCENT) of the contract value of the goods.

The Trustees' may, without prejudice to any other method of recovery, deduct the amount of such damages from any monies due or to become due to the contractor.

The payment or deduction of such damages shall not relieve the contractor from his obligation to complete the Works, or from any other of his obligations and liabilities under the contract. In case the bidder fails to complete the supply, some other agency may be ordered to supply the remaining materials at the risk & expense of the Bidder after a minimum three days notice in writing has been given to the bidder by the Manager (I&CF) or his representative. Deployment of separate agency shall be at the absolute discretion of the Manager (I&CF), whose decision will be final and binding.

14.0 FORCE MAJEURE:

In the event of either party rendered unable by Force Majeure to perform any obligation required to be performed by them under the contract, relevant obligation of the party affected by such Force Majeure shall upon notification to the other party be suspended for the period which Force Majeure events lasts. The cost and loss sustained by the either party shall be borne by the respective parties. The term "Force Majeure" as employed shall mean but not restricted to the events as below:-

- (i) riot (unless solely restricted to or perpetuated by employees of the Contractor / Suppliers or occurring outside India) so far as it is uninsurable.
- (ii) war, hostilities (wheather war war be declared or not), invasion, directed to or by India or act of foreign enemies, directed to India.
- (iii) rebellion, revolutions,insurrection, or military or usurped power, or civil war in India.
- (iv) Fire, flood, cyclone, hurricane and acts of God.

Upon the occurance of such cause and upon its termination, the party alleging that it has been rendered unable as aforesaid shall notify other party in writing immediately but not later than forty eight hours of the alleged beginning and ending thereof, gpving full particulars and satisfactory evidence in support of his claim.

Time of performance of the relative obligation suspended by the Force Majeure shall stand extended by the period for which such event lasts and affects the relative obligation directly.

15.0 SEVICE TAX:

The contractor, if registered with the central excise for the service to be rendered, copy of the registration certificate hall be submitted to H.D.C. The rate quoted by the contractor shall include Service Tax, if applicable for the contract. In case the contractor provides taxable service and charges service tax, the contractor will have to submit documents regarding payment of service tax and the bill / invoice / challan shall be so raised by the contractor as to enable HDC to obtain service tax credit against the same.

PREAMBLE TO THE BILL OF QUANTITIES

- 1.1 The Bill of Quantities must be read with the General Conditions of Contract, the Special Conditions of Contract and the Particular Specifications of Work and the Bidder is deemed to have examined the above documents and to have thoroughly familiarise himself with the detailed description of the works.
- 1.2 The quantities given in the Bill of Quantities are approximate only and are given to provide a common basis for tendering. Payment will be made according to the actual quantities of work ordered and carried out as jointly measured by the Engineer or his representative with the Contractor and valued at rates and prices finally accepted.
- 1.3 This being an item rate tender, the bidder shall quote his rates against all items both in figures & words. In case of any discrepancy, the rate given in words shall prevail over that in figures. The bidder shall calculate estimated amounts against individual items of work and after adding amounts against all items of works, shall mention the total amount in the "ABSTRACT FORM OF TENDER" AND "FORM OF TENDER" both in words and in figures..
- **1.4** During the detailed scrutiny and evaluation of tender any discrepancy or error found between the rate quoted by the bidder in figures and in words or in the amount worked out by him in the "Bill of Quantities" shall be corrected by tendering authority. In such cases the following methods shall be adopted for arriving at the final figures:-
 - (i) When there is a difference between the rate quoted in figure and in words for an item, the rate which complies with the amount worked out by the tenderer for this shall be taken.
